



Articulation Agreement between  
Bristol Community College  
and  
Northeastern University

This articulation agreement (this “Agreement”) dated August 12, 2025 is between Bristol Community College, a non-profit organization under the laws of Massachusetts with its principal office at 777 Elsbree St, Fall River, MA 02720 (hereafter referred to as ( “Bristol Community College”) and NORTHEASTERN UNIVERSITY, a non-profit corporation organized under the laws of the Commonwealth of Massachusetts with its principal office at 360 Huntington Avenue, Boston, MA 02115 (hereafter referred to as “Northeastern”).

It is agreed by and between Bristol Community College and Northeastern, for the mutual consideration and covenants herein contained, as follows:

1. Articulated Program. Bristol Community College and Northeastern hereby agree to an articulated program as stated in this Agreement, including the attached Appendix A, which is incorporated by reference, whereby certain students from Bristol Community College may complete a Bachelor degree at the College of Professional Studies (“CPS”) as long as they fulfill the prerequisites for the chosen program and are duly admitted as set forth herein.
2. Eligibility. Bristol Community College students who successfully complete the Bristol Community College associate degree, as further described in the attached Appendix B, in accordance with its published standards and subject to and in accordance with the limitations and procedures set forth in this Agreement, will be eligible for admission into CPS degree programs. Northeastern retains full discretion to make the final decision on each student’s application, and admission is not guaranteed.
3. Transfer Credits. Bristol Community College students who are admitted to CPS degree programs hereunder will be awarded a maximum of 60 transfer credits as set forth in the attached Appendix B. Appendix B may be amended at any time during the effective dates of this agreement by mutual agreement of Bristol Community College and Northeastern, including addition and deletion of designated courses. Such changes shall be agreed upon by both parties and confirmed by a written addendum to Appendix B signed by an authorized signatory of each party. In addition, either party may unilaterally amend Appendix B by written notice solely to identify specific changes to its courses (where such changes were made outside the scope of this Agreement) that should be reflected in Appendix B.

4. Requirements and Standards. Bristol Community College students accepted into CPS are subject to the graduation requirements of the college's catalog and other published standards issued by CPS and Northeastern in the year of their respective matriculation. Bristol Community College students are subject to changes that may be required to meet accreditation standards, including, but not limited to, those established by the New England Commission of Higher Education (NECHE) or those determined by Northeastern faculty as warranted to ensure a quality educational program.
5. Communications. The parties agree that their respective admissions offices, transfer staff, or other appropriate offices or designees will communicate at the beginning of each fall term to discuss recruitment, entrance requirements, and any other concerns that either may have about the affiliation. Other communications may be scheduled as needs arise. Each party agrees that it will notify the other party as soon as possible of any changes to its programs that will impact this Agreement. Each party shall provide the other with advance copies of, and an opportunity to correct or revise, any written materials that it publishes to describe the terms of this Agreement.
6. Marketing. With prior written approval of the other party, either party may advertise this articulation arrangement to its students, prospective students, and alumni through print, online, and interactive marketing materials such as fliers, websites, and other advertisements, subject to the guidelines and restrictions further described in this section.
  - a. Each party shall provide the other with a high-resolution logo file and hereby grants the other license to use the name and/or logo as set forth above.
  - b. Use of the Northeastern name shall be "Northeastern University, College of Professional Studies" in all communications. Shortened versions such as "Northeastern" or "NU" shall not be used.
  - c. Use of the Bristol Community College name shall be "Bristol Community College" in all communications.
7. Term. This Agreement is effective for eligible students who apply and are accepted into the Program starting in Fall 2025. This Agreement will continue in effect for an initial period of three (3) years. Thereafter, this Agreement will automatically extend for additional periods of one (1) year unless sooner terminated by either party, provided that the terminating party has given the other party written notice at least 90 days prior to the effective date of such termination and further provided that no such termination shall adversely affect any student then attending or accepted by Northeastern by virtue of the terms of this Agreement.
8. Confidential Information, Privacy and Security. All non-public information provided by or on behalf of either party (the "disclosing party") to the other party (the "receiving party") in connection with this Agreement is considered the disclosing party's confidential information ("Confidential Information"). The receiving party shall not disclose, access, or use, or permit others to disclose, access or use, Confidential Information except as expressly provided in this Agreement. The receiving party shall use reasonable and appropriate physical, technical and administrative measures to safeguard Confidential Information against any misuse or

accidental or unlawful destruction, loss, alteration, unauthorized use, disclosure, or access. If and only to the extent that either party receives or is provided access to information that can identify a unique individual, directly or indirectly, when performing its obligations hereunder, such party shall adhere to the requirements set forth in the applicable Northeastern Data Processing Addendum located at <https://generalcounsel.northeastern.edu/contracts-transactions/data-processing-addendum/> and in effect on the date of this Agreement.


9. Entire Agreement. This Agreement contains the entire agreement between the parties and may not be modified except by written agreement of the parties. This Agreement supersedes all prior communications, understandings, and agreements, whether oral or written, between the parties with respect to the subject matter hereof. All exhibits, addenda, attachments, and riders to this Agreement are attached and incorporated by this reference. This Agreement is separate from, and does not supersede, any existing agreement between the parties regarding other academic interactions.
10. Relationship of the Parties. The parties to this Agreement are independent contracting parties and nothing in this Agreement is intended, or shall be understood or construed, to create any relationship between the parties in the nature of joint venture, employment, agency, or partnership. Neither party shall have any power or authority to act on behalf of the other party or in its name or to bind the other party, either directly or indirectly, in any manner, nor shall either party make any representation otherwise to any person.
11. Miscellaneous. This Agreement shall be governed by and interpreted under the laws of the Commonwealth of Massachusetts, without regard to its principles of conflicts of laws. Each party shall comply with all municipal, state, federal and other laws, regulations, and accreditation standards applicable to its performance of this Agreement. Neither party may assign or otherwise transfer any of its rights or obligations under this Agreement to any person or entity without the prior written consent of the other party.
